

Cabby's Christmas Giveaway – Promotion Terms & Conditions

These Terms and Conditions (“Terms”) apply to the *Cabby's Christmas Giveaway* promotion (the “Promotion”) run by **Just Cabins NZ Limited** (“Just Cabins”). By entering this Promotion, participants agree to be bound by the following Terms.

1. Promotion Overview

- i. Hire a cabin between 12 Nov – 12 Dec 2025 and go in the draw to win one of 12 Ultimate Cabby Christmas Packs!
- ii. Winners drawn 13 Dec and announced on Facebook.
- iii. Terms apply.

2. Promotion Period

- i. The Promotion runs from 12 November 2025 to 12 December 2025 (the “Promotional Period”).
- ii. Entries received outside this time will not be eligible.

3. Eligibility

- i. The Promotion is open to New Zealand residents aged 18 years or older.
- ii. To qualify for entry, participants must hire a Just Cabin's cabin during the Promotional Period.
- iii. Entry is obtained through the hire of a Just Cabin during the Promotional Period. There is no alternative method of entry.
- iv. Each qualifying cabin hire counts as one entry into the prize draw.
- v. Employees, franchise owners, contractors of Just Cabins, and their immediate family members are not eligible to enter.
- vi. Just Cabins reserves the right to request proof of a qualifying cabin hire or any other verification deemed necessary to confirm eligibility.

4. How to Enter

- i. Eligible customers will be automatically entered into the prize draw when they hire a cabin between 12 November and 12 December 2025.
- ii. No additional or manual entry is required.
- iii. Customers who cancel their cabin hire before the prize draw date will no longer be eligible.

5. Prizes

- i. There are twelve (12) Ultimate Cabby Christmas Prize Packs to be won nationwide.
- ii. Each prize pack includes a curated selection of summer-themed and festive gift items (the “Prizes”).
- iii. Prize pack contents may differ from promotional imagery or descriptions due to stock availability.
- iv. Promotional images are for illustrative purposes only. Actual items may differ in style, colour, or brand due to availability.
- v. Clothing or wearable items are provided in set sizes for two children aged approximately 5–7 and 9–10 years. These items are not exchangeable for alternative sizes.
- vi. All prizes are non-exchangeable, non-transferable, and not redeemable for cash.
- vii. Just Cabins reserves the right to substitute any item within a prize pack with another item of equal or greater value if necessary.

6. Prize Draw and Winner Notification

- i. The prize draw will take place on 13 December 2025.
- ii. Twelve winners will be randomly selected from all eligible entries nationwide.
- iii. Winners will be notified by phone and/or email and announced publicly on the official Just Cabins Facebook page.
- iv. If a winner cannot be contacted within five (5) working days, Just Cabins reserves the right to select a new winner.

7. Prize Delivery

- i. All prize packs will be dispatched and delivered before Christmas 2025, wherever reasonably possible.
- ii. Delivery details will be confirmed directly with each winner.
- iii. Just Cabins takes no responsibility for lost, delayed, or damaged prizes once dispatched.

8. General Conditions

- i. By entering, participants agree that Just Cabins may use their name, region, and photographs for promotional purposes, without further compensation.
- ii. Just Cabins reserves the right to verify eligibility and to disqualify any entrant who tampers with the entry process or breaches these Terms.
- iii. Just Cabins’ decisions regarding all aspects of the Promotion are final and no correspondence will be entered into.
- iv. Just Cabins will not be liable for any loss, damage, injury, or disappointment suffered by any participant resulting from entering this Promotion or accepting any prize.
- v. The Promotion is governed by the laws of New Zealand.
